Buyer agrees to have his/her puppy examined by a licensed veterinarian of their choice within (5) five business days of purchase (receiving) and to have the Veterinary Examination Report completed by the attending veterinarian. The report must be returned to seller immediately following the examination. Failure to return written report within 24 hours of exam invalidates this contract. This report may be faxed to (214)276-1673. If your puppy, in the opinion of the veterinarian, has any physical problems considered to be life threatening, I will provide you with a healthy replacement puppy of equal value. If there are no puppies available, one will be provided from the next available litter whelped. If a buyer chooses a puppy of greater value, then he/she will be responsible for the cost difference. To make a claim you must return your puppy to us within 7 days of purchase. Also, provide a signed statement from the veterinarian proving date of examination and an explanation as to why the puppy is a poor health risk. The statement must include a description of the symptoms supporting the opinions. There will be no refund on shipping charges, miscellaneous charges necessary for transportation of puppy to/from this location.

**Note:** There is no guarantee against Hypoglycemia, Coccidiosis, Parasites, and Viral or Bacterial Infections. We do not cover Cherry Eye, Entropion or Demodex due to the fact that this is very common in Bulldogs.

**Your puppy has one year Life Guarantee**

Should the puppy die of a birth defect within one year of the time of purchase, "YourPuppyLuv" will provide a replacement puppy. To qualify for this guarantee, you must have kept the puppy under the care of a licensed veterinarian. The care must include all vaccinations recommended by the veterinarian. To make a claim, you must bring a signed certificate from the veterinarian stating the cause of death and a copy of ALL of your puppy's health records.

**General Terms and Conditions:**

Failure to have the puppy examined within (5) five days of purchase VOIDS ALL Guarantees. If you are not provided with a replacement puppy within 180 days of guarantee claim, (of same sex, breed, and retail value of original puppy purchased), then you will be entitled to a full cash refund of your puppy's original purchase price. Shipping price and Miscellaneous charges necessary for transportation of puppy to/from this location will not be refunded. The puppy cannot be returned after the quarantine period has expired and/or if it has been exposed to another animal, which has not been kept current on their vaccinations.

It is the responsibility of the buyer to provide immediate veterinary care to any puppy showing signs of illness or distress & failure to do so will render any guarantee null and void. Under no circumstance is a puppy to be destroyed prior to notification by the seller. If a puppy dies within the guarantee period, despite medical treatment, replacement will be made ONLY if a veterinarian certifies the cause of death. Seller will not be held liable for any medical or behavioral problems due to transit. Veterinarian or Emergency Veterinary care expensed incurred by the buyer, for any reason, will Not be Joulia Prous's responsibility

If a puppy is being returned for any health guarantee claim, you must also return all registration papers. Registration papers must be signed, transferring ownership back to Joulia Prous will not be held responsible for any costs accrued after the sale is final.

Guarantee is not valid in case of accidental death or injury.

This contract is Null and Void if the terms and Conditions are not fulfilled & if the contract is not signed & returned back to me within 2 weeks of purchase.

**Note:** There is no guarantee that this puppy can be shown or bred.

**Note:** There is no guarantee on the color or size of puppy now or as an adult.

**I, the buyer of a puppy from seller hereby acknowledge that I have received a copy of this document. Further, I accept the terms and conditions of the guarantee for congenital or hereditary disorders printed in this document, and I waive and relinquish any and all other rights that I might otherwise have in the event of such occurrence. In the event of any litigation in connection with this Guarantee, seller will be paid reasonable attorney fees by the buyer. Venue and jurisdiction for litigation arising out of or related to this contract shall lie exclusively in Sellers County and State. Purchaser acknowledges that he or she has read, understands and agrees to the terms of this document.**
